Ever since we last spoke, my financial and personal situation has become impossible. As you may remember, my son stole all of the money that I had worked for during the last 2 years for my retirement. In addition, he illegally took \$20000 promised to the IRS. When they became aware of this, they began proceedings against me. We were suddenly unable to pay our mortgage and other bills. My wife worked for a short time as a caregiver to help us to survive. Her employer took advantage of our situation and paid her only \$5/hr. For this she took care of three non- ambulatory persons. Lifting them gave her great pain, as she has a bad shoulder.

So this morning, I got my computer working and checked to see the ad for the Cabo rental. There was none. I checked "

Mexico Timeshare" and it did not appear. I checked resorts, and "WorldMark Coral Baja" is not even in your resort drop-down list. How can this be? No one could possibly find this rental, no matter how hard they looked! I did finally find the ad under
