This is in regard to your dispassionate and condescending response to my last email. Although I am 81, I do recall that we had a conversation in October. Not only that but I am also capable of detecting your "spin" on that conversation – specifically, that it was "extensive".

The word "extensive has no bearing at all with the way my case has been handled! You didn't address a single point that I addressed, except BAE Systems. Your response to that reveals how utterly disconnected you are with my case. Not that it matters to you, but I was a Consultant to the SW Test Manger - not an employee. I was forced out because myself and the other two most experienced SW Test Analysts informed management that there were things happening that could adversely affect the safety of our troops. This was the major thrust of one of my initial two letters/emails sent to Congresswoman Eshoo on October 2, 2014. I authored a detailed "BAE Systems Report" which defined me as a "Whistle Blower". BAE Systems used the legal system to ruin me financially as payback for that report. This caused me to be unable to pay my income taxes for 2008. I was aware that President Obama had signed, in 2009, "The Federal Contractor Whistleblower Protection Law" and requested your help in how to apply it to what had been done to me.

My second letter/emails sent to Congresswoman Eshoo on October 2, 2014 detailed what the IRS did to me over several years since 1967. I requested to be informed on how they could get away with what they did, especially to my wife. I am aware of the Freedom of Information Act, and believed that you could provide me with the information requested. Instead, it is obvious that you took a couple of items TAS, and The Art Institute of Pittsburgh which you then turned over to other persons or agencies. It is very clear that you consider me only as a line item in your to do list. Your words – "I am sorry to hear" are one degree of separation from caring, which obviously you do not in any way. Since I am ill, I proposed that I come to your office. Your email could have said "Yes let's do that, but you obviously don't want that in a big way, but rather to write me off instead.

Clearly the purpose of your email is to state that you have checked my line item off and that you are done with me - "go away and die for all I care!"

I would hope that Congresswoman Eshoo does not know how this "case" has been handled. If so, and this is how a constituent is treated then the Democratic Party is not that different from the Republicans. That being so, how stupid I have been in believing that the Democrats stood up for the middle class. I guess that all has been reduced to politics only. I contributed as much to the party as I could, at times even when it cost me in other ways. I worked the phones several times for President Obama, and as of now, I believe only in him.
