

Update 3/10/2015

Not only has my wife's brain tumor doubled in size, but my recent appointment with my kidney specialist (**Dr. Archana N. Dhawan, San Jose**) revealed that my kidney function has decreased by 17 points. It was 50% functional, and is now 33% functional. She worries that the increased Quinapril, prescribed for my recent high blood pressure is a contributing factor.

All of this is caused by the stress of our financial situation exacerbated by the IRS and my Federal Student Loan. My wife once again postponed having her tumor removed, as her not being able to work could cause homelessness. I have tried and failed to get Congressional help, so we continue to live with stress, fear and hopelessness.

In 1967, Representative Don Edwards went face to face with IRS and ended their assault on me and my then wife. I perhaps naively expected similar help, but received only a token response. So very soon I expect that FedLoan Servicing will begin taking money from my Social Security, which IRS is currently taking \$248/month. How we can survive much longer appears impossible – less food, less needed medication, highway accident due to our dangerous to drive vehicle? I just don't know!

My wife received notification that her 2014 tax refund was applied to **my** 2002 taxes. I didn't know this previously, but all of her tax refunds have been thus applied. This is incredibly wrong and unjust! We were not even married in 2002! It's just another way to increase forever what we owe on our 2008 taxes – more interest - more penalties!!!

Taxpayer Advocate Service
